Withdrawals and/or Dismissals

A written notice of intent to withdraw a student from Midland Valley Christian Academy must be submitted, acknowledged and settled prior to 2 weeks before the last day of attendance. All grades and records will be held until all outstanding balances are paid. Withdrawal from MVCA must be signed and processed through the Administration Office. An account left open will incur additional tuition fees and late fees until withdrawal papers are returned to the administration office.

In the event of withdrawal from Midland Valley Christian Academy all rights are waived to a refund of tuition and fees previously paid. Parents/Guardians shall remain obligated by signed contract to pay the 2015-2016 school tuition and fees unless the following applies:

- * When the parent or guardian moves out of town or a distance that the school sees as unreasonable to transport the child to and from school.
- * When there is a mutual agreement between the parents/guardian and the school that is in the best interest of the student to pursue the student's education with curriculum material more suited to the student's personal learning needs.
- * If there is a loss of income, equal to the amount of tuition, such as a job in the immediate family of the student.
- * Should a student contract a serious illness that would prevent him/her from attending school. Documentation from a physician is needed.
- * Death of the student

In the event of dismissal/expulsion from Midland Valley Christian Academy all rights are waived to a refund of tuition and fees previously paid. Parents/Guardians shall remain obligated by signed contract to pay the 2015-2016 school tuition. A student will be dismissed/expelled for the following:

- * Violation of School policies as outlined in MVCA Handbook.
- * A student's conduct, attitude, or lack of academic effort makes it mandatory for that child to withdraw from MVCA.
- * Tuition is 30 days delinquent.
- * Parents/Guardian/Student are not in harmony with the mission and philosophy of Midland Valley Christian Academy.
